

## Job Description and Person Specification

<b>Job Title</b>	Integrated Non-Custodial Service Mental Health Treatment Requirement Practitioner CRIMINAL JUSTICE TEAM
<b>Salary</b>	£30,000 per annum pro rata (Salaries are reviewed annually)
<b>Annual Leave</b>	26 days per year and bank holidays and statutory holidays. 1 additional day of annual leave per year for each full financial year continuously employed by DHI, up to a maximum of 31 days annual leave per year.
<b>Pension</b>	Contributory pension scheme, where DHI contributes 7% and the employee contributes a minimum 3% of their salary tax free.

## **Purpose**

- Promote social inclusion and independence.
- Work alongside people experiencing mental health difficulties using a person centered approach to support them in achieving their goals.
- This post will work closely with our criminal justice partners, including prisons and courts, to deliver high quality services that support people whose offending is associated with mental health issues. The criminal justice team also supports clients to reduce substance use and offending behaviour, providing real opportunities for recovery and to reduce harm to communities and individuals.

## **Responsibilities**

### **Person Centred Service Delivery**

- Provide a welcoming reception, offering information, advice and guidance to support an individual to access the right service (DHI, DHI on-line or other).
- Work in a way which enables clients and communities to access a wide range of support, so they may exit the service as early as possible and sustain positive change.
- Undertake assessments and develop person centred support plans in collaboration with those requiring support. Person Centred assessments and Support Plans are tailored for and driven by the client, recognising their resources, strengths, aspirations and needs. Assessments and plans look beyond the presenting 'problem' and support clients to progress toward goals and aspirations using all available resources (e.g. clients' support network, online help, DHI and external agencies, clubs, activities and services).
- Support people to move through the service using the support plan as a dynamic document for change and give feedback on progress.
- Monitor and document the progress of individual clients, maintaining accurate, up-to-date, and confidential records that provide essential data.
- Identify, address, advocate, and escalate issues with clients as appropriate.
- The worker will support a whole-system approach with criminal justice partners to engage clients in treatment and support their recovery. The role is embedded in the Criminal Justice community treatment service, which has a specific outreach and engagement remit to work across Prisons, Police, Liaison and Diversion Schemes, Courts and Probation.
- This role will hold a caseload of clients involved in the criminal justice system, specifically those sentenced to Mental Health Treatment Requirements in the Bristol and Bath courts and who reside in Bristol, South Gloucestershire or BANES.
- The MHTR intervention involves 12, 50 minute sessions across the Community Order as specified by the Court, where the individual meets with the Primary Care MHTR Practitioner overseen by the Clinical Lead. The timing of sessions within the Community Order will be determined in the Post Sentence Case Management Meeting, considering other requirements and their interdependencies.

### **People and Performance**

- Participate fully in regular supervision, team meetings, appraisals and learning and development activities.

- Contribute to a positive, collaborative, and person-centred culture and model DHI values in your behaviours.

#### **Compliance**

- Understand and adhere to all DHI's policies and procedures as well as good practice guidelines, legal and regulatory requirements.

#### **Other**

- This job description contains only the main accountabilities relating to the post and does not describe in detail all the duties required to carry out the role.
- The post holder will be expected to undertake any other duties reasonably requested by their manager and commensurate with the expectations of the role.

### **Skills, Knowledge, Experience, and Behaviours**

The most important quality to succeed in this role will be your positive attitude, resilience, and enthusiasm for the work of DHI and your team.

- Good communication skills, written and verbal.
- Undertaking assessments and producing support plans within a health or social care setting.
- Experience delivering mental health interventions.
- Ability to plan, prioritise, and organise your own work and time.
- Good basic level of IT literacy (proficient in Word, sending emails and able to input data into systems following training).

- Able and willing to travel around the geographical area covered by the service.

#### **Desirable Criteria:**

It is **desirable** that you can demonstrate: **Experience**

- Working in a criminal justice setting, or with people involved in the criminal justice system.
- Working with Dual Diagnosis. **Skills and Qualifications**
- Brief solution focused counselling, CBT, motivational interviewing or coaching skills or qualification.

All the above skills, knowledge, experience, and behaviours will be tested at application and interview.
